If involved in equine activities pursuant to Section 3.1-796.132 of the Code of Virginia the undersigned(s) execute(s) this waiver of the undersigned(s) rights to sue and agree(s) to assume all risks inherent in equine activities and have notice of all the risks inherent in equine activities including (i) the propensity of equine to behave in dangerous ways which may result in injury to the participant; (ii) the inability to predict an animal's reaction to sound, movements, objects, persons, or other animals; and (iii) hazards of surface or subsurface conditions.

All equine entries must present proof of a negative Coggins test within the last twelve months upon registering. The Coggins number must be listed for each horse.

 - At least 20-foot intervals between entries should be maintained throughout parade.

I understand that the Highland County Fair Association, Inc. parade chairperson(s) and volunteers will exercise safety precautions as best as possible for all entrants. Failure to sign this form and present proof of negative coggins test (for equine entries) could result in dismissal from parade. All entries are required to smile, wave to crowd, and have a genuine good time! ☺
