- Vehicle has been checked for any safety concerns and is in proper working order. Any vehicle unable to complete the parade route will be towed at owner's expense.
- Hitches are secured.
- All items/decorations are safely secured on float/vehicle/wagon
- People on floats or moving units are safely positioned on unit in order to prevent falls or other injury.
- At least 30-foot intervals between entries should be maintained throughout parade.
- Be mindful and cautious of pedestrians along route.

Failure to sign this form and present proof of negative coggins test (for equine entries) could result in dismissal from parade. All entries are required to smile, wave to crowd, and have a genuine good time! ☺

EQUINE ENTRIES

If involved in equine activities pursuant to Section 3.1-796.132 of the Code of Virginia the undersigned(s) execute(s) this waiver of the undersigned(s) rights to sue and agree(s) to assume all risks inherent in equine activities and have notice of all the risks inherent in equine activities including (i) the propensity of equine to behave in dangerous ways which may result in injury to the participant; (ii) the inability to predict an animal's reaction to sound, movements, objects, persons, or other animals; and (iii) hazards of surface or subsurface conditions.

All equine entries must present proof of a negative Coggins test within the last twelve months upon registering.

The Coggins number must be listed for each horse.
