The Highland County Fair Association, Inc. reserves the right to limit the participation of any entry for any reason. All entries are required to smile, wave to crowd, and have a genuine good time! 😊

If involved in equine activities pursuant to Section 3.1-796.132 of the Code of Virginia the undersigned(s) execute(s) this waiver of the undersigned(s) rights to sue and agree(s) to assume all risks inherent in equine activities and have notice of all the risks inherent in equine activities including (i) the propensity of equine to behave in dangerous ways which may result in injury to the participant; (ii) the inability to predict an animal's reaction to sound, movements, objects, persons, or other animals; and (iii) hazards of surface or subsurface conditions.	
All equine entries must present proof of a negative Coggins test within the last twelve months upon registering.
